- I. Call to Order – President Anna Leigh Rossi began the meeting at 10:04am.
- II. - III. Approval of Agenda – Ms. Kar-Kay Cassady made a motion to approve the agenda. Ms. Cala Flippo seconded and the motion carried.
- IV. Approval of Minutes – Mr. Jeremy Martin made a motion to approve the October 2025 meeting minutes. Ms. Debbie Williams seconded and the motion carried.
- V. Staff Senate President’s Report –President Anna Leigh Rossi shared that the Shared Governance Executive Committee has been tasked with reviewing the recommendations from the Review of Shared Governance Policies and Practices (report). She has asked that all Senators share the report with their constituents and constituents submit any recommendations via the available Qualtrics form by November 18, 2025. President Anna Leigh Rossi also shared that open enrollment for FSA and HSA account is currently available until November 14<sup>th</sup>.
