- SGA 5k
 - Our team met to discuss our plans going forward for the race.
 - Registration is now back open again! Please share this with everyone interested in running. We are not searching for more sponsors, but we are searching for more runners.
 - The flyers have been made with the new date, and we are ordering more shirts for our new runners.
 - We are looking at potential food trucks who can come to the race, since some of the other food trucks that we had for the original date can no longer be there.
- Parking
 - We are looking at a new electric vehicle, the GEM e6, to replace the SNAP golf cart.
 - This is a pretty cost-efficient option, and it has plenty of seating for multiple students to ride in it.
 - President Mardis explains the benefits of these electric vehicles, and how much one might cost.
 - DIA Saunders thinks implementing the use of this vehicle would be a great idea!
 - Chairwoman Rhoades asks what training would look like for students to be able to use one of these vehicles.
 - Matthew thinks this is a good idea because this expands the reach of SNAP.
 - President Mardis also discussed the idea of adding specific locations on campus for this vehicle to stop at.

NEW BUSINESS

- Bill 25-13: Freshman Spring Social T-Shirt Funding Bill
 - Freshman Forum Advisor Anthony and Freshman Forum Advisor Ballenger will be presenting the sole piece of legislation on the docket on the Senate floor today.
 - This bill will be allocating funds from the miscellaneous line so that Freshman Forum can have branding for their event!
 - They both described what this bill entails and what all will be happening at their event.
 - Chairwoman Rhoades asks how much money is left in the miscellaneous line.
 - There is an amendment on the floor for this bill. The amendment is accepted by the authors of the bill.
 - Pro-Tempore Fitz appreciates the effort for this amendment, but she thinks it would be more straightforward to pass this bill as it was originally written.
 - Treasurer Batchelor informs the Senate that North Alabama Screenprint says something different every time an invoice is placed for shirts.
 - Chairwoman Thomas thinks that if something is up for subjection, we should actively work to combat this subjection.
 - There was a motion to vote on this amendment. The motion was heard and properly seconded.

- The amendment was passed by the Senate. This amendment will now be included in the bill.
- There is another amendment on the floor for this bill. The amendment is accepted by the authors of the bill.
- DIA Saunders believes that verbiage that is currently in the bill may be up for conjecture by the student body. He asks the Senate to keep this in mind when voting on this bill.
- There was a motion to vote on this amendment. The motion was heard and properly seconded.
- The amendment was passed by the Senate. This amendment will now be included in the bill.
- Freshman Forum Advisor Ballenger would like to reiterate that this bill will be for the children (Freshman Forum).
- Senator Joyner asks who will receive the remaining shirts from this event.
- President Mardis says that we do have the funds to provide shirts for this event. She thinks this is a good event that showcases Freshman Forum's initiatives and is a great opportunity for them.
- Freshman Forum Advisor Anthony says that this event will provide a way for Freshman Forum to create a bigger splash on campus and getting their name out there to students.
- Chairwoman Winston makes a motion to go into a vote on this bill. This motion was heard and properly seconded.
- This bill was passed by the Senate as amended. Congratulations!
- Review Allocations Manual
 - Chairman McCuiston will be presenting the revised allocations manual to the Senate.
 - He explains the committee's reasoning for each of the suggested changes that were made to the manual.
 - Senator Huffman asks if there is still an appeal process during the allocation process.
 - Chairwoman Hamilton thinks the manual looks great and that the Senate should vote in favor of it.
 - Matthew provides clarification surrounding the reasoning for these changes.
 - Chairwoman Hamilton moves to go into a vote on the revised changes. This motion was heard and properly seconded.
 - The changes were passed as presented. Congratulations!
